# **Sharing personal information**

We will share your personal information with third parties where required by law, where it is necessary to administer our relationship with you, where we have any other legitimate interest in doing so or you have specifically provided your consent.

We may disclose aggregate statistics about members, visitors and supporters to describe our services and operations to prospective partners, advertisers, funders, other reputable third parties and for other lawful purposes. These statistics do not include information that identifies people.

# Lawful basis for processing personal information

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

#### **Legitimate Interest**

We have a legitimate interest to do so in support of the objectives of the Witney Food Revolution. When processing your personal information based on a legitimate interest, we will make sure that it is exercised proportionately and is always balanced against the privacy and other legal rights you have as an individual.

#### Your consent

You provide your consent for us to process the information. You are able to remove your consent at any time. You can do this by contacting the email address above.

#### Vital interest

To protect your vital interests or those of someone else in an emergency.

#### Legal

We have a need to use such information in connection with a legal claim.

## **How we protect your Personal Information**

Electronic data and databases that contain personal information about members and volunteers are stored on encrypted secure computer systems and we manage who has access to that data (using both physical and electronic means).

All hard copy records and data are limited, minimised and held in access restricted storage.

### How we store personal information

The Witney Food Revolution is based in the UK. Wherever possible we store our information about members and volunteers in the UK or within the European Union (EU).

We only use and store your information for as long as it is required for the purpose it was collected for. We continually review what personal information and records we hold and delete what is no longer required.

# **Your Rights**

We want to make sure that you are able to make informed choice about hoe we use your personal information and to do so you must understand your data protection rights:

- The right of access to your personal information. You can request the personal information
  we hold by making a subject access request to the email provided above.
- The right to have your personal information we no longer need erased from our records.
- The right to have inaccurate personal information amended
- The right to ask us to stop using your personal information in certain situations.
- The right to object to your information being used for marketing or profiling.
- A right in certain circumstances to have a copy of your personal information provided for reuse in another service.

It you would like further details or would like to exercise any of your rights, please email us at the address provided. We reserve the right to ask for further information to verify your identity when we receive such a request.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
